God End Abortion and Send Revival to America

Thirty seven years ago a court case infamously called *Roe v. Wade* entered the United States Supreme Court. The court decision decided that abortion would be legalized in the United States. As a result, today this nation has killed 51 million children of the next generation. That is about one sixth of America's population crying from the ground. The abortion movement and the lowering of the sanctity of life may have come by surprise to the masses of people in America, but the Supreme Court case came to pass because of a movement that was birthed in the early twentieth century called Eugenics. Abortions do not only affect unborn children, but they also affect the parents, brothers, grandparents and even friends of the unborn baby's parents. Many people see abortions as a quick escape out of a pregnancy, but abortions physically, mentally, and spiritually destroy the family. It is proven that an abortion experience can produce depression and even suicidal thoughts in the mother's mind because they not only killed their own child; they killed part of themselves. The opposition to the death culture of abortion is no longer at rest and is refusing to be silent. There are more pregnancy centers today in America than abortion clinics. For the first time in the history of the United States since 1973 there is a pro-life majority. Some of this majority is Christian forerunners, who want to see laws in Congress that allow abortions to be banned. Abortion must be eradicated from this nation completely because it was introduced by an immoral Eugenics movement that lowered the very value of life, it destroys families and especially mothers. A pure pro-life movement must arise to counter the death culture in this nation and execute righteousness and justice from the east to the west coast of America.

“We hold these truths to be self-evident, that all men were created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty, and the pursuit of Happiness” (The Declaration of Independence). This document was written more than two hundred years ago in 1776 by our Founding Fathers. It could possibly be one of the most foundational documents of United States of America. Yet that foundation has been battered and weakened over the

last hundred years as opposition has hit the Declaration of Independence. In the last thirty-seven years America has defied the unalienable right of life. The moral decay of the sanctity of life was not the first right that was defiled in this nation, but instead it was the right that all men are created equal. In the early twentieth century, the Eugenics movement reached the United States and it devalued the first unalienable right of the Declaration of Independence. The word eugenics in the late 1800s labeled this movement and was created by Sir Francis Galton. The two words come from the Greek language. The first word is “eu” which means good and the second word is “gen” which means birth or race. The eugenics theory is that good and bad traits are hereditary and Galton addressed that it was possible to “eliminate the undesirables and multiply the desirables”. This is not just a theory; what Galton proposed was a scientific way to support racism. Galton was influenced by the philosophies of Charles Darwin and Thomas Malthus who both believed that in a world of people, the weak minded must be eliminated due to a lack of resources; Darwin coined this as natural selection. The theory of evolution combined with eugenics to create this “elitist, racist movement that sought to remove all those believed inferior”. According to Galton, the inferiors and undesirables were all the “mentally handicapped, physically handicapped, blind, poor, and colored portions of society”. This is an important reason of why racism towards African American continued after the civil war, it was fueled by the Eugenics movement. Galton’s theory also established the reasoning for abortions. Galton died in 1911, but the dream that he had of eugenics came to pass in 1933 when Adolf Hitler rose to power and formed the Third Reich in Germany. Hitler made Germany a radical eugenic nation and created a white supremacist race called Aryans. Everyone who was considered undesirable was sent to prison and death camps and thus created the Holocaust which occurred in the 1930s and 40s. “Hundreds were killed in the camp labs in the name of eugenic research. In Auschwitz alone, 1,300 people were killed in twin experimentations”. At the end of World War II the Eugenics movement came to a screeching halt when justice and life’s sacredness was once again reestablished. This was best seen in the Nuremberg trials in Germany when all the leaders who practiced eugenics were put on trial and killed. Though the

Eugenics movement was stunted after World War II, in America there was one woman who completely changed the face of eugenics to take on a different form so that it would not fail like it did in Germany; her name was Margaret Sanger. Margaret Sanger went deeper than Galton and believed in birth control, sterilization and eugenics as a way to eliminate the undesirables. Short after the Eugenics movement began birth control followed and Sanger was one of its leaders. Margaret Sanger said, “‘the dead weight of human waste’ should be ‘eliminated’ ”. Margaret did not support abortion openly because she thought that “society was not quite ready for it”. Therefore Sanger trained society and was the founder of Sanger's American Birth Control Federation in 1922 which today is called Planned Parenthood. In 1930, Sanger opened up a clinic in Harlem New York and her teachings brought forth a moral decay in this nation that still continues today. Sanger taught that birth control and not prenatal care would produce healthier children. Most of her words were lies because today many practices of birth control today are abortifacients and not contraception. She was teaching a watered down version of abortion by teaching the citizens of Harlem about birth control. The undesirables in Sanger's eyes were the same as in Hitler’s and Galton’s; those who were inferior to the culture and the colored portions of society. One of the main priorities that Margaret Sanger had was to eliminate the African American race. This is the reason why her clinic was centered in Harlem, which is a high minority and low income district of New York City. Margaret Sanger regarded the African American population as “human weeds” and “intolerable breeders”. This is why in Sanger's early forties she created the Negro Project which was planned to exterminate the African American race. Sanger writes in a letter, “We do not want word to go out that we want to exterminate the Negro population, and the minister is the man who can straighten out the idea if it ever occurs to any of their more rebellious members”. Therefore Sanger seduced much of the African American population to follow her demands. She was sending the next generation of the black population of America to their death beds and the African Americans thought she was helping them. To make matters worse, the Church, who should have been outright against this Eugenics movement were actually working with Sanger as the moral standard of life in American

slowly began to recede. America had begun to lose its biblical foundation of what the sanctity of life really is. The Founding Fathers who were mostly Christian men knew the value of life for it says in Jeremiah 1:5 “Before I formed you in your mother's womb, I knew you”. The Founding Fathers knew that it was God who created man and gave them certain unalienable rights, but man's ambitions of racism were defiling those rights. Instead of children being seen as a blessing from God, Margaret Sanger, known as an extreme feminist, taught that multiple children were a ball and chain to mothers. When the first birth control pill came out in 1956, it was tested in Puerto Rico because of the colored population before it was introduced into America. The only problem was that abortion was illegal in the 1950s so Planned Parenthood and other organizations silently moved its way to legalize abortion in the United States. With the combined efforts of the eugenics, birth control, sterilization, and the new abortion movement and with no strong righteous, truthful opposition to this blasphemy of this racist agenda, in January 22, 1973 abortion was legalized by the Supreme Court decision of *Roe v. Wade*. However the abortionist leaders were not satisfied and therefore *Doe v. Bolton* entered the Supreme Court which allowed legalized abortion in all three trimesters of pregnancy for virtually any reason. So the patient could say that they simply wanted an abortion because the baby was unwanted and the doctors would commence the procedure. Both court cases legalized abortion not just for special conditions, but for abortions on demand. The *Doe v. Bolton* Supreme Court case was very deceptive to begin with. “Mary Doe's real name was Sandra Cano. Her husband was in jail, her kids had been placed to foster care, and she was pregnant at the time the lawyers approached her. When she agreed to be Doe, she thought it was to get a divorce and to get her children back”. She had no idea that the lawyers wanted to legalize abortions in every trimester of pregnancy. The lawyers tried to convince her to have an abortion, but she knew it was wrong. Planned Parenthood continues in this sly evil way of deceptive business today. Planned Parenthood is now creating Abortion Clinic super centers. They have already built one in Aurora, Illinois in secret so that no one knew that it was a Planned Parenthood building until it was already built. Planned Parenthood is now creating another abortion super center in Houston,

Texas and it was to be the second largest abortion clinic in the world. One of the floors is going to be used it to practice Partial-Birth abortions which were banned in the United States in April 18, 2007, but Planned Parenthood found a loophole in the law. Planned Parenthood takes its roots in eugenics and built the abortion super center right in the middle of four highly minority districts that make a low median Per-Capita of \$11,637 a year. It is the exact same strategy Margaret Sanger had in 1922. The abortion movement has its roots in eugenics because the RU-486 birth control pill “was created by the same company that created Zyklon B gas for the Nazi death chambers. America is on a tightrope and is teetering, ready to fall in the disaster of infanticide in a nation that says all men are created equal. “Not one school-based Planned Parenthood clinic is located in a white majority school” because that is not what the abortion industry wants, they want the African American “undesirables”. Planned Parenthood's plans so far have done terrible damage to the African American population. “Each year 616, 074 African American are born. 484,500 babies will have died from abortion. 284,877 blacks will have died that same year through anything from natural disaster to heart disease. There are 743,377 African Americans dying yearly. This number is 127,303 more than those that are born”. The African American population is actually decreasing in the United States. Sanger's views towards genocide have deceptively begun to accomplish its primary goal which is to eliminate the African American undesirables. Defiling the unalienable right to life and that all men created equal is immoral, unlawful, unbiblical, and incorrect. Someone must speak for those who cannot, and for those who are ignorant to understand that the abortions not only kill innocent babies, but also create long term mental, physical and spiritual conditions that change your life from the moment you have the abortion procedure.

All abortion decisions affect every aspect of the mother and father’s life. Today there is a Post Dramatic Stress Disorder (PTSD) that is specified strictly towards those who have had abortions and it is called Post Abortion Stress or Post Abortion Syndrome, which is abbreviated a PAS. Some mental symptoms that occur are “anxiety disorders, nightmares or sleeping disorders, flashbacks to the abortion experience, suicidal thoughts or acts” and “other self destructive activities”. A woman by the

name of Geraldine writes about her symptoms of Post Abortion Syndrome when she says, “I truly felt like the abortionist ripped out my heart and soul...It was a pain so heavy, on more than one occasion I found myself contemplating suicide. I overdosed on pills more than once”. Abortion leaves mothers in utter despair. Many mothers are forced to have an abortion by their husband, boyfriend or family members. The mother in many situations seems like she is surrounded by the abortion option when she has an unexpected pregnancy. The mother is seen like a victim feeling that no one really loves her and that she has no purpose. The mother feels that she is only used as an object and not as a prize to be respected. This devastates her goals she has in life thinking she is no longer helpful to society. The society of America has lied to the people saying that birth control is important when it only increases perversion in a nation and makes people more sexually active. When people are more sexually active, with or without birth control, contraceptives, or abortifacients they are more likely to get STDs which are sexually transmitted diseases. Two diseases that may develop from being sexually active are HIV (human immunodeficiency virus) and AIDS (acquired immunodeficiency syndrome) which is routinely fatal. In 2002, out of the 886,575 cases of AIDS in the United States 501,669 died from it. Other diseases that could form as a result of sexually active people thinking that birth control and contraceptives completely covers them are PID (pelvic inflammatory disease), HPV (human papillomavirus), Chlamydia, Gonorrhea, Syphilis, Genital herpes, Hepatitis B and Hepatitis C. These are the most common of diseases that result from sexually active people as millions of people get infected with these diseases each year in the United States. Though these diseases are sexually transmitted, there are also health risks that come from the medical surgical abortion. Hemorrhaging can be a result from an abortion procedure and the former mother might have to go back to the hospital to receive a blood transfusion or even a hysterectomy; which is cutting open the woman’s stomach to stop the bleeding. Infection also may occur after an abortion because sometimes the abortionist accidentally could leave part of a baby's hand, foot, or leg in the mother’s womb and if this is left untreated this could result in infertility. Perforation or the puncturing of the uterus wall by an abortion tool is also a

common complication. This could mean major surgery after the abortion to repair the damage that was made when the unborn baby was innocently killed. A woman who's had two or more abortions causes them to have a higher chance of a miscarriage pregnancy later in life. Abortions also can cause higher chance of having an ectopic or tubal pregnancy. This happens when the fetus is growing in the fallopian tube instead of in the uterus which is dangerous and potentially fatal for both the mother and the unborn baby. Abortions also increase the chance of breast cancer. The abortion procedure also causes death in rare situations because of severe bleeding or complications with the drugs given to them. Many people who say they have had abortions say that they feel far away from God because deep inside, no matter who persuaded them to have an abortion they know that they have killed an innocent life. Abortion has affected the next living generation of Americans. They feel abandoned that no one told them about the destruction of abortion. Millions of teenagers, young adults and even children are trapped in sexually transmitted disease because the culture of America says you can have "safe sex". This however is a lie because no condom and no contraceptive device can completely and fully ensure that the woman will not get pregnant or if one of the partners will get an STD. There is only one way for a woman to stay pure from any STD and an abortion and that is by practicing sexual abstinence until marriage and remaining faithful to him or her just like the vows spoken on a wedding day. The question that arises is how can a man or a woman stay pure in a culture that is gripped with pornography, abortions, and human trafficking? There is only one way to live pure and that is by following the One who creates life and that is Jesus Christ. This answer is beginning to be heard in this nation as a pure pro-life movement shouts that God is the only remedy for this nation.

Ten years ago a man by the name of Lou Engle in the fall of 2000 gathered tens of thousands of Christians on the national mall praying to God to end abortion in this nation and send revival to America. From then on the pro-life movement has exploded all across the nation. In 2004, a small group of prayer warriors stood in front of the Supreme Court steps and had tape over their mouths which said LIFE. The movement has never ceased and even today there is a group of intercessors out in

front of Supreme Court declaring the reversal of *Roe v. Wade* before it ever happens in the natural.

Those who were sexually active and have lost their virginity but are grabbed by the power of God and His pro-life movement are now committed to secondary virginity where they will no longer have sex with anyone until they've married. Since ultrasounds were invented, more people in this generation are seeing what their baby looks like and cannot kill their very own child. Crisis Pregnancy centers are now being built across the streets from abortion clinics. In a foundation called *No, Not This One*, whenever a Crisis Pregnancy Center has a woman who is considering an abortion, the employee texts Christians to pray and this movement has been successful. In one of the chapters in Oklahoma they have had a one hundred percent success rate where prayers of the intercessors changed every woman's mind to have an adoption or care for the baby in this Crisis Pregnancy Center. In the abortion clinic super center in Houston, Texas, the building is not being built without a holy opposition. On Martin Luther King Jr. day this year, thousands of Christians prayed and marched around the super center for it to close down and for that building to be a gathering place where His presence may dwell. People who were conceived in rape are confessing that they are full with an exuberance of joy to know that they are alive today and were not aborted. This movement is not getting small but is getting bigger by the moment. Now the teenagers are getting the message and are declaring the sanctity of life in their school and its corridors. Every Friday in many junior high schools and high schools, kids are praying to end the racism, violence and immoral acts of abortion in this nation. At the end of their prayer meeting with their friends they say this 22 word prayer, "Jesus, I plead Your blood, over my sins, and the sins of my nation. God end abortion and send revival to America". No matter what opposition comes against them their voices will not be silenced and they are willing to risk their lives to end abortion, whatever it takes, these prayer warriors shall gladly do it for the glory of Jesus' name.

Abortion is outright wrong in every way. It began through deception and its roots are in racism to wipe out whole cultures that are seen as "undesirable". Abortion in America came to defile the very rights of the Declaration of Independence and it defiled the sanctity of life. President Thomas Jefferson

once said, “The care of human life and not its destruction...is the first and only legitimate object of good government”. The United States has fallen under a corruption that has killed fifty one million babies along with mothers plagued with abortion complications and STDs, fathers grieving over their killed children, and a death rate of African Americans bigger than the birth rate; mainly because of abortions. This nation must become aware of the abortion destruction or else the unborn children’s blood will cry out from the ground. In Genesis 4:10b after Cain had killed Abel; the Lord said to Cain, “What have you done? The voice of your brother’s blood cries out to me from the ground”. There needs to be a change, not simply a revolution, but a restoration in the way the people of America view God. He is the only One who can cleanse this nation from the innocent blood that has been spilled. For the glory of Jesus’ name, this is restoration, this is the way.
